

Cookie Policy

Through our websites and our third-party providers, Banner Business Solutions Ltd T/A Complete set and use cookies to store and manage user preferences, enable content, gather analytic and usage data, and generally improve your user experience. This policy sets out what type of cookies we use, how we use them, and how you can control and manage them.

What is a cookie?

A cookie is a small text file that is placed on a computer or other device. It is used to identify the user or device and to collect information. Cookies are typically assigned to one of four categories depending on their function and intended purpose: strictly necessary cookies, performance cookies, functional cookies, and cookies for targeting and advertising purposes.

Types of cookies and why we use them

Strictly necessary cookies

These cookies are necessary for the website to function and cannot be switched off in our systems. Without these cookies, services you have asked for, like adding items to the shopping basket, logging in or filling in forms cannot be provided. You can set your browser to block or alert you about these cookies, but some parts of our website may not then work.

These cookies do not store any personally identifiable information.

Performance cookies

These cookies allow us to count visits and traffic sources so we can measure and improve the performance of our site. They help us to know which pages are the most and least popular, see how visitors move around the site, and whether they clicked on a link such as an explicit opt-in to marketing. This lets us know where we are doing well, and where we can improve, as well as making sure the pages load quickly and display properly. Information collected might include, for example, the internet browsers and operating systems used, the domain name of the website previously visited, the number of visits, average duration of visit, and pages viewed.

All of the information collected by performance cookies is aggregated and therefore anonymous. If you do not allow these cookies we will not know when you have visited our website and will not be able to monitor its performance and enhance your experience. We use services from Google to perform these functions.

Functionality cookies

These cookies enable the website to provide enhanced functionality and personalisation by remembering choices you make (such as your username or ID, language preference, or the area or region you are in). They may also be used to provide services you have asked for, such as watching a video or viewing product datasheets. They may be set by us or by third party providers whose services we have added to our pages. The information these cookies collect may be anonymized, and they cannot track your browsing activity on other websites. If you do not allow functionality cookies, then some or all of these services may not function properly.
